2. What does the French Paradox refer to?

RAW Resveratrol™ is a highly potent source of polyphenols, providing 350mg of *trans*-Resveratrol per serving, as much *trans*-resveratrol as in 200 bottles of red wine, supporting numerous systems, including the circulatory, respiratory, reproductive and digestive systems.

5. How much Resveratrol does RAW Resveratrol[™] provide?

resveratrol. This step is essential because resveratrol is present in very low concentration and polydatin is not bioavailable to the body. The process uses low temperatures resulting in a cleaner product and helps concentrate the Resveratrol and remove Emodin. The fermentation process allows us to avoid the use of chemicals to concentrated the resveratrol.

10. What is Emodin?

A: Emodin is a resin found in Japanese Knotweed and other plants; it is associated with dyspepsia (stomach or GI discomfort) and diarrhea, so controlling emodin is essential. Garden of Life uses fermentation to remove emodin.

11. Does RAW Resveratrol[™] include probiotics and enzymes?

A: Yes, RAW Resveratrol[™] includes the RAW Probiotic & Enzyme Blend to aid digestion. [†] This blend is composed of the probiotic *Saccharomyces boulardii*, and the enzymes Protease, Phytase, beta-Glucanase, alpha-Galactosidase, Hemicellulase and Cellulase.

12. Does RAW Resveratrol[™] contain Organic Fruits and Vegetable juices?

A: Yes, it contain the RAW Organic Antioxidant Blend composed of 5 fruits and berries (Organic Strawberry, Organic Cherry, Organic Blackberry, Organic Blueberry and Organic Raspberry); and 17 vegetable juices (Organic Beet Juice, Organic Carrot Juice, Organic Spinach Juice, Organic Broccoli Juice, Organic Tomato Juice, Organic Kale Juice, Organic Red Cabbage Juice, Organic Parsley Juice, Organic Brussels Sprout Juice, Organic Green Bell Pepper Juice, Organic Cucumber Juice, Organic Celery Juice, Organic Garlic Juice, Organic Ginger Juice, Organic Green Onion Juice, Organic Cauliflower Juice and Organic Asparagus Juice).
